3. To pay current replacement value in the event of loss or covered through independent coverage.
4. To have the instrument assessed at the end of the contract period and pay a fair assessment for all damage in excess of normal wear and tear.
5. To allow no unauthorized person to play, handle, or use this instrument without specific permission of the director. NOTE: This instrument MAY BE ASSIGNED TO MORE THAN ONE STUDENT. Each student shall be afforded equal home practice time and taken into consideration for any repair assessment. Repairs due as a result of damage or neglect other than normal wear and tear will be paid for by the student(s) responsible.
6. To encourage my child to use the instrument to the best of his /her ability for serious study including regular attendance at all organization rehearsals and performances, regular home practice and additional instruction and study when possible.
7. Excessive neglect or abuse of a school owned instrument by a student will result in removal of the instrument from the student.
8. Instrument rentals are available to be enrolled, active members of the instrumental music department.
9. Noncompliance of the above rental policies can result in the permanent removal of the school instrument from the student.
