

## **RAFFLE OFFICIAL RULES AND REGULATIONS**

Maverick Band Booster, Inc. (herein referred to as “MBB”), a non-profit Florida corporation, is a tax-exempt organization under federal and state law. MBB is conducting this raffle pursuant to Section 849.0935, Florida Statutes, as a way to raise funds for the Miami Arts Studio Band Magnet. The official Rules and Regulations of MBB’s raffle are set forth below. By purchasing a raffle ticket, you agree to be bound by these Rules and Regulations. MBB’s interpretation and application of the Rules and Regulations shall be final.

### **TICKETS**

Tickets may be purchased for the suggested minimum donation of \$10.00 per ticket, payable to Maverick Band Booster, Inc.. A maximum of 10,000 tickets will be sold.

Raffle tickets must be purchased in person by 7:30 p.m. on May 2, 2024. Any purchase request received after this time will not be accepted. No refunds are available. MBB assumes no responsibility for lost, misdirected, or otherwise failure to deliver tickets prior to the deadline. Purchases of raffle tickets are not tax-deductible contributions.

No purchase or contributions are necessary to participate in this raffle. Limit one free ticket per person. The person requesting a ticket at no cost must send their name, address, and phone number on a 3x5 card along with a self-addressed stamped envelope to Maverick Band Booster, c/o Miami Arts Studio 6-12 @Zelda Glazer, 15015 SW 24<sup>th</sup> St, Miami, FL 33185. Postmark may not be later than ten (10) days prior to the date of the drawing.

### **HOW TO PURCHASE**

Tickets may be purchased in person at MBB, from the event coordinator or assigned volunteers of MBB. Tickets may be paid for by cash, check, or credit card. MBB reserves the right to limit the number of tickets distributed to each person. All ticket purchases are subject to these Rules and Regulations.

### **SELECTION OF WINNERS**

ONE winning ticket will be selected at random at the Milton Center for Performing Arts, 15015 SW 24<sup>th</sup> St, Miami, FL 33185, on or about 9:00 p.m. on May 2, 2024, from all eligible raffle tickets received. MBB will conduct the drawing during or immediately after the spring concert of the Miami Arts Studio Band Magnet. Ticket holders do not need to be present to win. The winner will be notified by phone or email based on the contact information provided to MBB at the time of purchase. The odds of winning the prize are one (1) in 10,000.

### **ELIGIBILITY**

You must be 18 years of age or older and a resident of the United States to purchase a ticket and win the prize. All federal, state and local laws and regulations apply. The raffle is void where

prohibited or restricted by law. If it is determined that this raffle is not permitted in this or any jurisdiction, refunds shall be limited to the lesser of the price contributed or \$10.00.

## **PRIZES**

One prize will be awarded. The raffle drawing is as follows: The grand prize is a 2024 Mazda CX-30 (donated by Ocean Mazda).

## **RESTRICTIONS**

No substitutes for prizes will be made. The winner assumes all local, state, and federal income taxes and incident expenses not mentioned herein. Any payment of income tax withholding will be required at the time of transfer of the prize to the winner (at our discretion). If the winner cannot be located within 30 days of the event, after making reasonable attempts to do so, or if the winner is deemed to be ineligible, such winner will be deemed to have forfeited his or her prize, and another winner will be selected for such prize. The winner must claim his or her prize within 30 days after notice of the award. If the winner does not claim the prize within such a 30-day period, such winner will be deemed to have forfeited his or her prize and another winner will be selected for such prize. The name of the winner may be obtained by request, in writing, to MBB, together with a self-addressed, stamped envelope, postmarked no later than June 1, 2024.
